### **Overall RDRC Goals**



Research and evaluate a wide array of topics related to Social Security's **Old-Age, Survivors**, and **Disability Insurance** (DI) and **Supplemental Security Income** (SSI) programs and related federal policies;



Disseminate information on these topics to policymakers, researchers, stakeholder organizations, and the general public; and



Provide training and education to scholars and practitioners in research areas relevant to these topics.

### **RDRC Research**

Successful proposals follow these guidelines:

#### Significance/Relevance

Research on topics related to Social Security, retirement, and disability policy. Most importantly, proposals must make a strong case for how the research would contribute to knowledge about Social Security populations, policies or programs, explaining how the project directly impacts SSA or SSA beneficiaries.

#### **Data/Methodology**

Proposals clearly state the research questions and aims, describe the data and its appropriateness, and then provide a step-by-step narrative of how the methods will address these questions.

#### **Investigators**

Proposals often have at least one PI with an extensive publication record in the research area. Early stage researchers should include a senior researcher as a co-PI on the proposal, even if that researcher is only acting in a supporting/mentoring role (and receives little to no funding for themself).
